**Multimillion-Dollar Renewable Energy Company Coming to Colorado**

Renewable Energy Systems Americas, Inc. (RES-Americas) announced it will move its headquarters, along with 140 jobs to Broomfield, CO. Of the 140 jobs, 70 will be re-located from the company's former Texas-based headquarters. The other 70 jobs are planned to be filled by local hires, according to RES-Americas. - *9News.com*

**VMware Growing in Colo., Bringing Jobs**

The new owners of bankrupt Adam Aircraft hope to bring back 100 employees to the reconstituted company and revamp operations at Centennial Airport within a month, they say. - *Denver Business Journal*

In what local officials called a momentous day for Colorado Springs, the U.S. Olympic Committee agreed to keep its headquarters in the city for at least another 25 years. The USOC employs 330 people locally, pumps about \$341 million annually into the local economy and enhances other industries such as tourism and retail. - *The Gazette*
